- 3. What do mental rotation tasks suggest in relation to theoretical perspectives on imagery?

- 4. Why was Chomsky's work considered important in the development of cognitive psychological accounts of sentence comprehension?
- 5. Briefly outline 3 types of inferences that are used in discourse comprehension.
- 6. What are the main stages of speech production, as outlined by cognitive psychologists?

#### (c) ATTENTION

- 7. Describe Lavie's Theory of Perceptual Load.
- 8. Outline the differences between automatic and controlled processing using Schneider and Shiffrin's theory.
- 9. Explain the Flicker Paradigm in terms of perceptual processing.

#### (d) COGNITION AND EMOTION

- 10. Give one example of how emotions can affect decision-making.
- 11. Describe the notion of 'mood congruent memory'.
- 12. Describe the main difference between emotional response and emotional experience.
